

Privacy Policy for Valinity

At Valinity Labs S.A.S, accessible from valinity.io and the Valinity app, one of our main priorities is the privacy of our visitors. This Privacy Policy document contains types of information that is collected and recorded by Valinity and how we use it.

This Privacy Policy applies only to our online activities and is valid for visitors to our website and mobile app with regards to the information that they shared and/or collect in Valinity. This policy is not applicable to any information collected offline or via channels other than this website.

Consent

By using our website and mobile app, you hereby consent to our Privacy Policy and agree to its terms.

Information we collect

We collect usage data for the purposes of analytics and error reporting. This information may include pages viewed, IP addresses, and types of devices used. No personal data is collected, as we do not ask for users to disclose any such information when downloading or creating an account with Valinity.

Log Files

Valinity follows a standard procedure of using log files. These files log visitors when they visit websites. All hosting companies do this and a part of hosting services' analytics. The information collected by log files include internet protocol (IP) addresses, browser type, Internet Service Provider (ISP), date and time stamp, referring/exit pages, and possibly the number of clicks. These are not linked to any information that is personally identifiable. The purpose of the information is for analyzing trends, administering the site, tracking users' movement on the website, and gathering demographic information.
